### **New Business:**

- **Rule book discussion** Per Amy the rule book will need typed since it has been copied so many times but is usable for now
  - Suggestions around missing information fees, lifetime memberships, make future changes in a way that minimizes the need for updates, questions around who has the right to do photography at events, what calculation will be used in the event of a tie, and clearer language around drugged horses (i.e. removed from the grounds and/or tested)
  - Rider/horse combination award changed to high point rider for both youth and adult.
